## General Instructions For Filling Out Absentee Ballot Application

### 1. The applicant is to complete Section 1

- a. The applicant for an absentee ballot must have the application completed then signed before a witness who is 18 years old or older.
- b. Thumb prints or other identifiable marks, such as an "X" mark are allowed for applications involving individuals who are unable to sign their names.

### 2. Section 2 is to be completed by the witness

### 3. Time Periods and Deadline

If mailing the application, it must be physically present in the Navajo Election Administration Office by the set deadline date.

### 4. Completed faxed applications are not acceptable
